

**Subject: Complaint Summary Report for Calendar Year 2013**

**CALEA Standard 52.1.5**

The purpose of this report is to summarize the data provided by the Departments' tracking of complaints against its members. Complaints are categorized as either a complaint which is denoted as having a "C" in the complaint number or as an Internal Affairs Investigation which is denoted as having an "IA" in the complaint number.

This report is the result of a review of 11 complaints received by the department as well as 11 Internal Affairs investigations for calendar year 2013. The data shows the complaint number, date of complaint, the type of complaint and the resolution.

The resolutions for these complaints can be found as one of the following five categories:

Exonerated – allegations have been verified, but actions resulted from adherence to proper and appropriate police procedures and techniques.

Sustained – allegations true and disciplinary action taken.

Not Sustained – unable to verify truth of the matters under investigation.

Unfounded – no truth to the allegations.

Administratively Closed – closed due to lack of cooperation from the complainant or where the investigation was closed due to there being no means by which to continue the investigation.
