

## WHAT IS THIS NOTICE?

Timely Warning notifications are released by the George Mason University Department of Police and Public Safety (Mason Police) to alert the campus community about crimes that pose a serious or continuing threat to safety. These public notifications are intended to enable campus community members to protect themselves.

*Trigger warning: This notification addresses two separate sexual assaults.*

### **To the George Mason University Community,**

Mason Police is giving notice of two separate sexual assaults that occurred in student residence halls on the Fairfax Campus.

- On Friday, March 18, 2016, at 10:12 PM, Mason Police received information that a female student was raped sometime late in the evening of Thursday, March 17, 2016 either in a student residence hall on the Fairfax Campus, or in an off-campus apartment, by a male student known to the victim. The victim may have unknowingly ingested an unidentified drug prior to the alleged assault.
- On Monday, March 21, 2016, at 2:15 AM, Mason Police received information that a female student was raped approximately one hour earlier in her student residence hall on the Fairfax Campus by a male subject, unaffiliated with GMU, whom the victim met through an online dating application.

## SEXUAL VIOLENCE RISK REDUCTION

Mason Police reminds members of the Mason community of the following information to help reduce the possibility of victimization and to enhance opportunities to deliver assistance (Note: the following information is general in nature and does not relate to any specific incident):

- Always seek verbal, sober, and clear consent before a sexual act. Immediately stop sexual advances if the other person indicates no interest or if they say “no.” Consent to one sexual act does not imply consent to another. The absence of “no” does not mean “yes.”
- If you’re not sure that you’re getting a clear, enthusiastic “yes” from your partner, it is your responsibility to ask.
- You cannot assume that you have consent because someone is not physically resisting or verbally refusing sexual contact.
- Consent is not to be inferred from silence, passivity, or a lack of resistance.
- Unreasonably pressuring or coercing someone into engaging in sexual activity is sexual assault.

- If you are ever in a situation on campus where you are unsure or scared, call Mason Police immediately at 703-993-2810 or 9-1-1 (for Mason Korea, call 1-1-9).
- If you witness a situation that appears unsafe or makes you uncomfortable, intervene if it's safe to do so, elicit help from a friend, or go to a safe area and call for help.
- Seek medical help immediately if a friend starts to exhibit symptoms of dizziness and/or nausea, memory loss, breathing or motion difficulties, or is acting disproportionately intoxicated relative to the amount of alcohol ingested.
