## **CLERY ACT 101: Campus Safety is Everyone's Responsibility**

The Clery Act is a federal consumer protection law requiring institutions of higher education to comply with certain campus safety- and security-related requirements as a condition of participating in the Federal student financial aid programs authorized by Title IV of the Higher Education Act.<sup>1</sup>

### Overview of "Major Players" and *Some* of their Responsibilities:

#### **Mason Police**

- Collects crime reports from Campus Security Authorities (CSAs) and local law enforcement agencies with jurisdiction over Mason's properties.
- Prepares and disseminates required campus safety-related information for public viewing, including:
  - Annual Security & Fire Safety Report;
  - Daily Crime & Fire Log;
  - <u>Timely Warning Notifications</u>; and
  - o Emergency Notifications.
- Maintains <u>programs</u> designed to inform students and employees about campus security procedures and practices and the prevention of crimes.

# Environmental Health & Safety (EHS)

- Collects fire statistics relative to each on-campus student housing facility.
- Assists in the preparation and dissemination of campus fire safety-related information for public viewing, including:
  - Annual Security & Fire Safety Report;
  - Daily Fire Log; and
  - Emergency Notifications.

### **University Life**

- Maintains educational programs and campaigns related to the prevention of sexual violence and drug and alcohol abuse.
- Offers confidential and non-confidential support resources for students and employees.

### **Clery Compliance Coordinator**

- Ensures Mason's compliance with the Clery Act.
- Submits crime and fire statistics to the <u>U.S.</u> Department of Education.
- Maintains and publishes policies and procedures addressing campus security and safety.
- Oversees training of all CSAs.

### **Campus Security Authorities**

(CSAs) – All employees and students with significant responsibility for student and campus activities\*

- Immediately report Clery Act Crimes to Mason Police in one of three ways:
  - Calling Mason Police directly at 703-993-2810 (911 for emergencies);
  - Completing the CSA Crime

¹ The Clery Act is named in memory of Jeanne Clery, a Lehigh University student who was sexually assaulted and murdered in her on-campus dorm room in 1986. The U.S. Department of Education enforces the Clery Act. Each violation of the Clery Act is subject to a civil penalty of \$54,789.
