

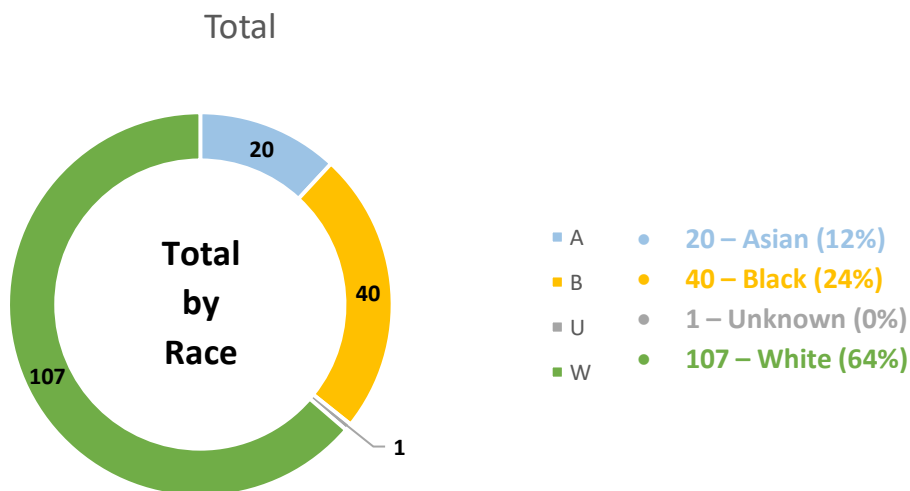

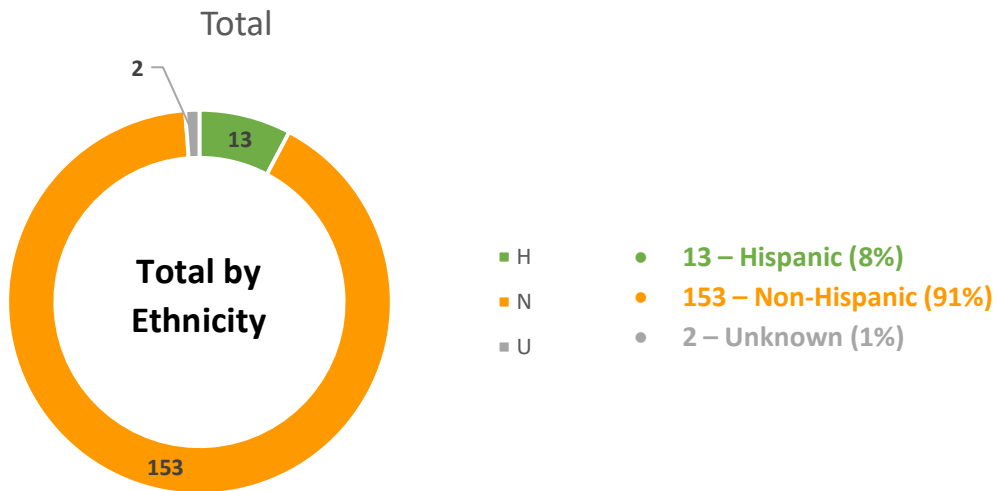

There were a total of 168 traffic stops from Jan. 1 2021 – Mar. 31, 2021.

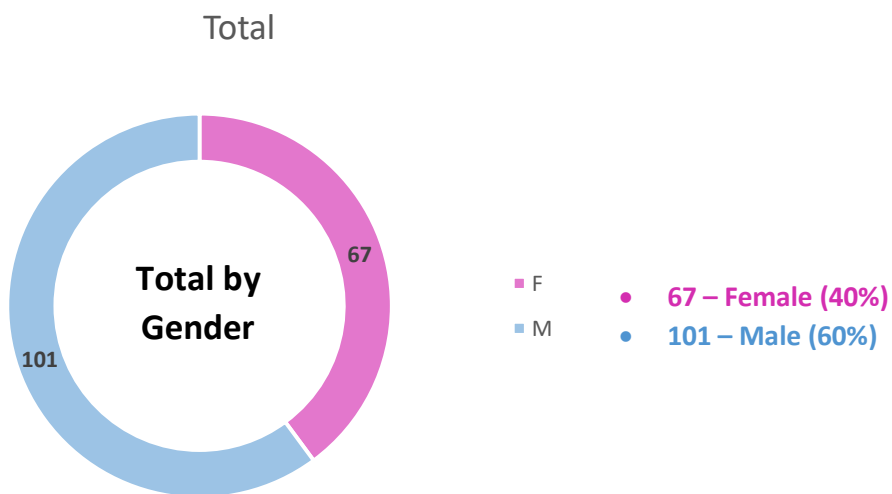
Of the 168 traffic stops, the following chart depicts the race of drivers upon officers initiating a traffic stop and making contact.



Of the 168 traffic stops, the following chart depicts the ethnicity of drivers upon officers initiating a traffic stop and making contact.

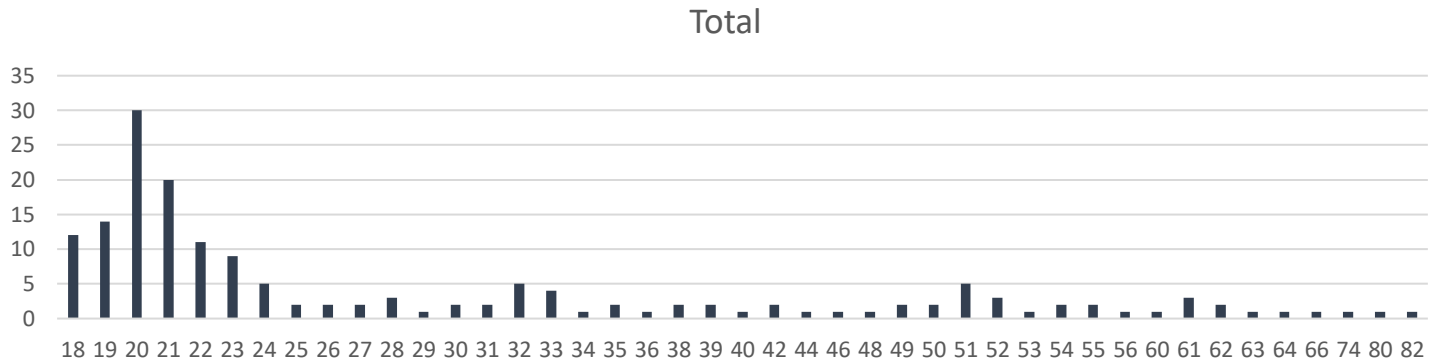


Of the 168 traffic stops, the following chart depicts the gender of drivers upon officers initiating a traffic stop and making contact.

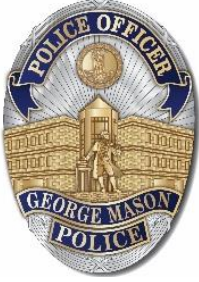

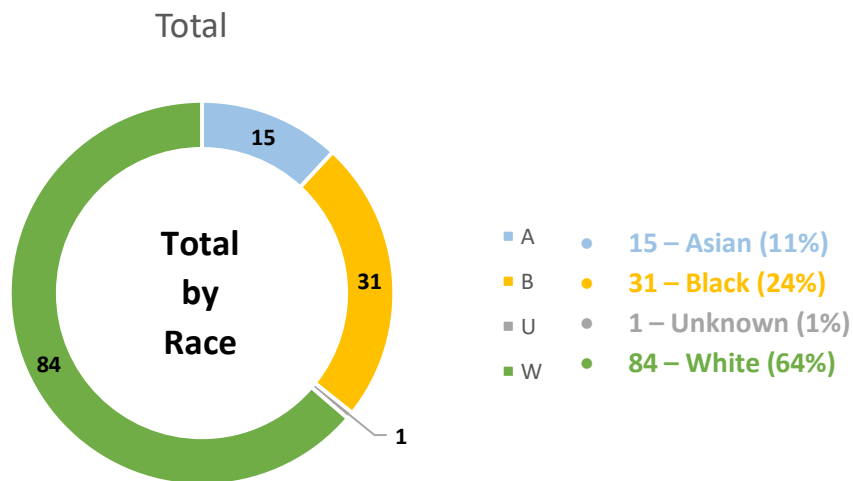

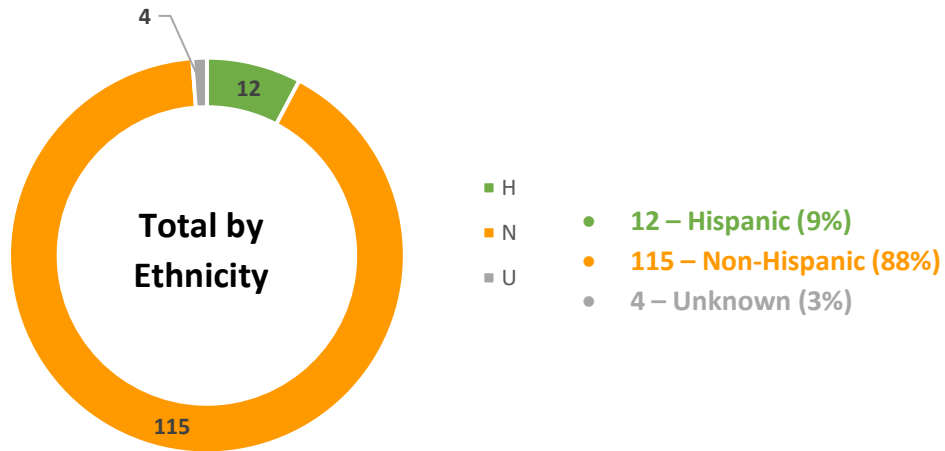

There were a total of 131 traffic stops from April 1, 2021 – June 30, 2021.

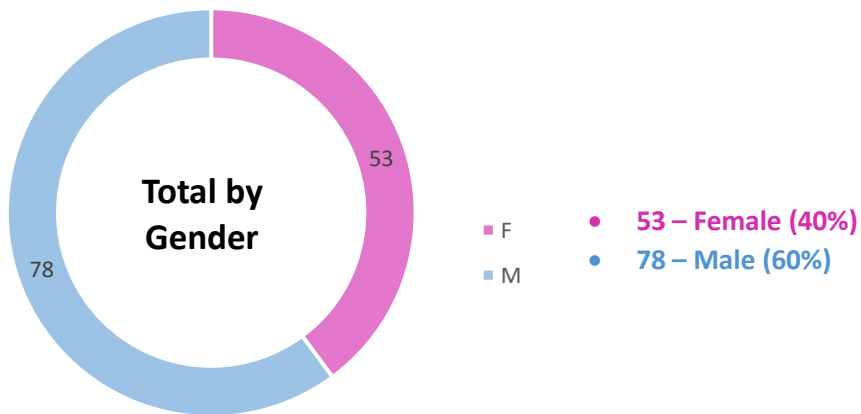
Of the 131 traffic stops, the following chart depicts the race of drivers upon officers initiating a traffic stop and making contact.



Of the 131 traffic stops, the following chart depicts the ethnicity of drivers upon officers initiating a traffic stop and making contact.

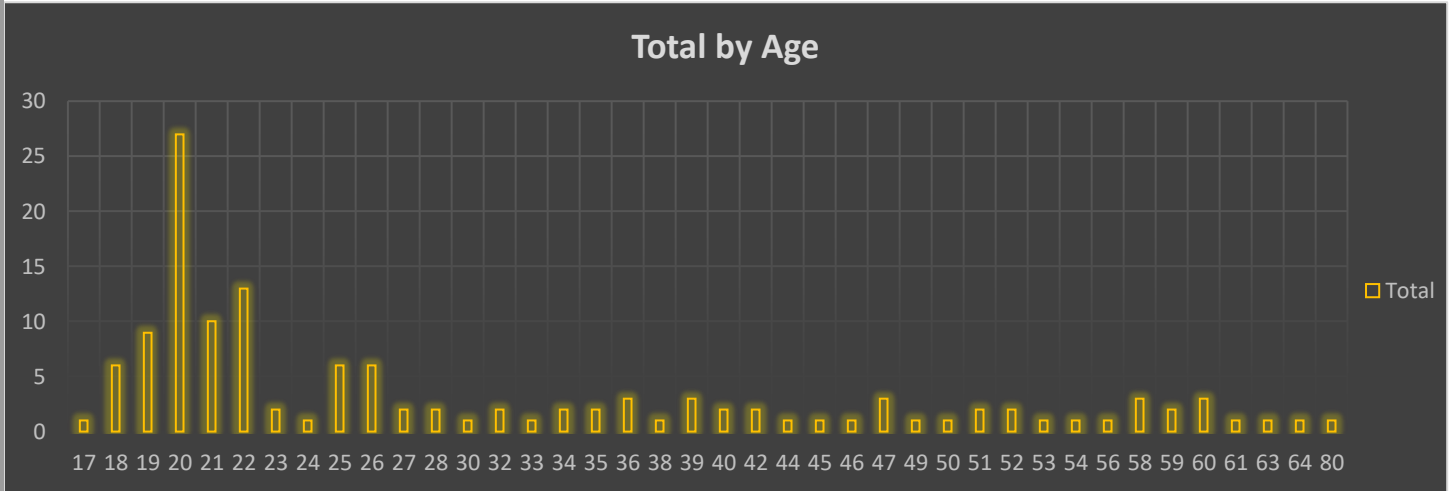


Of the 131 traffic stops, the following chart depicts the gender of drivers upon officers initiating a traffic stop and making contact.

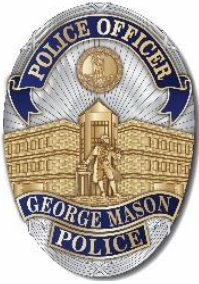

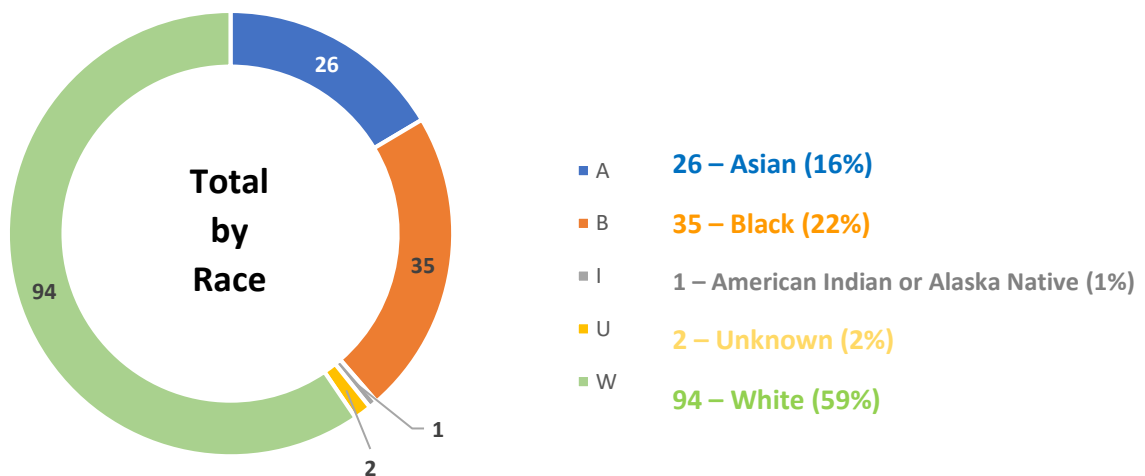

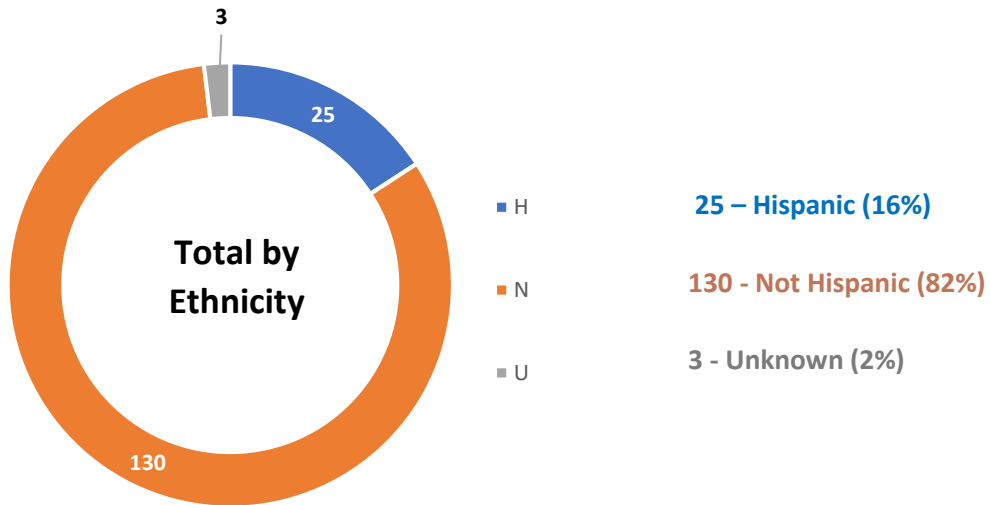

There were a total of 158 stops from July 1, 2021 – Sept. 30, 2021.

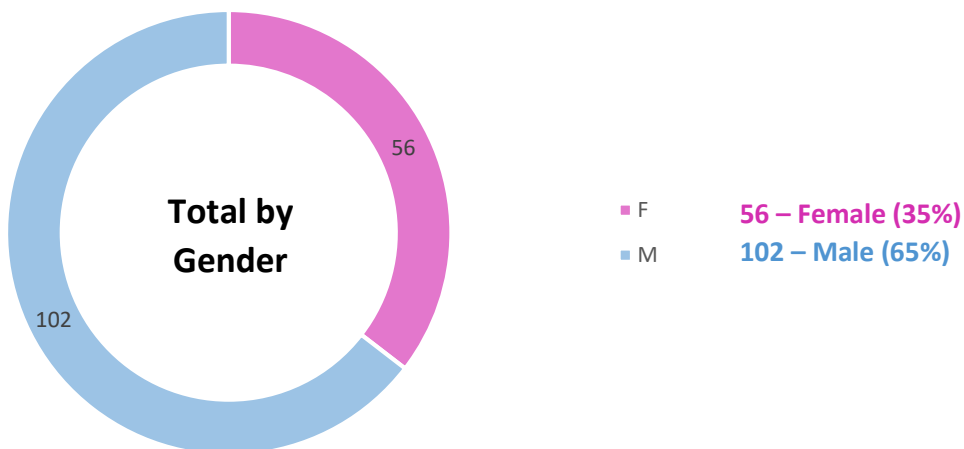

Of the 158 stops, the following chart depicts the ethnicity of individuals upon officers initiating a stop and making contact.



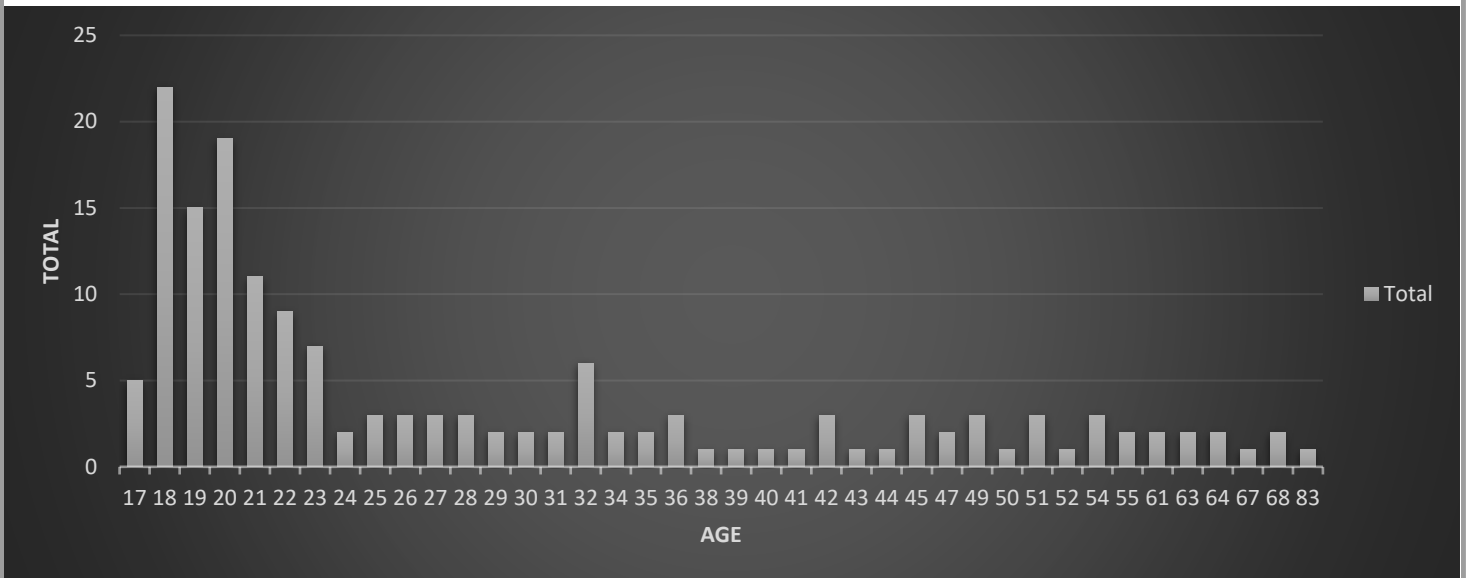

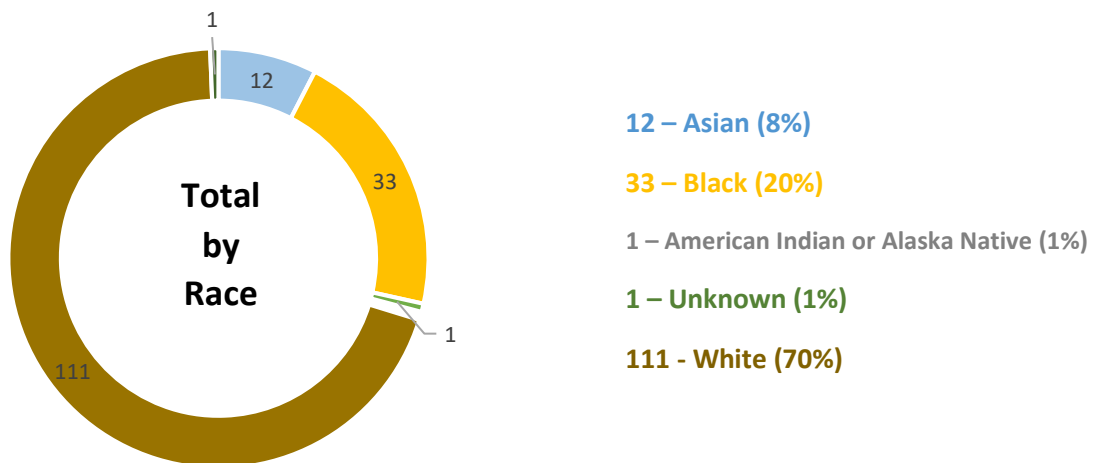

**Oct. 1, 2021 – Dec. 31, 2021**



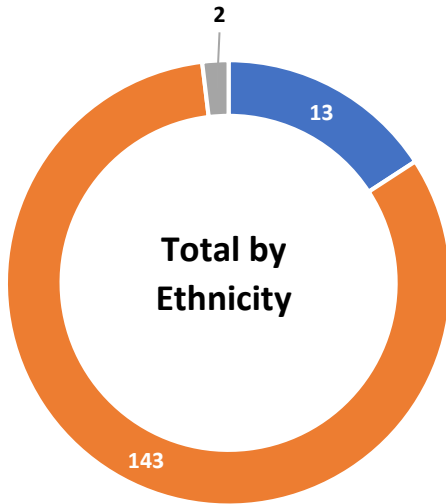

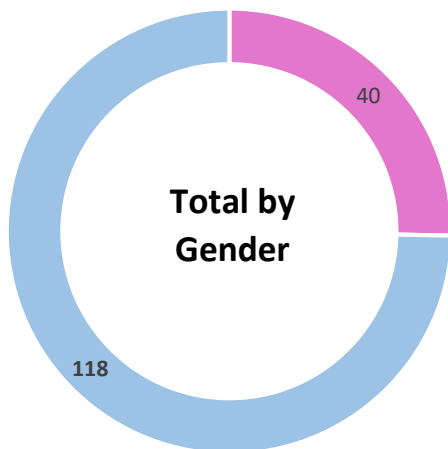

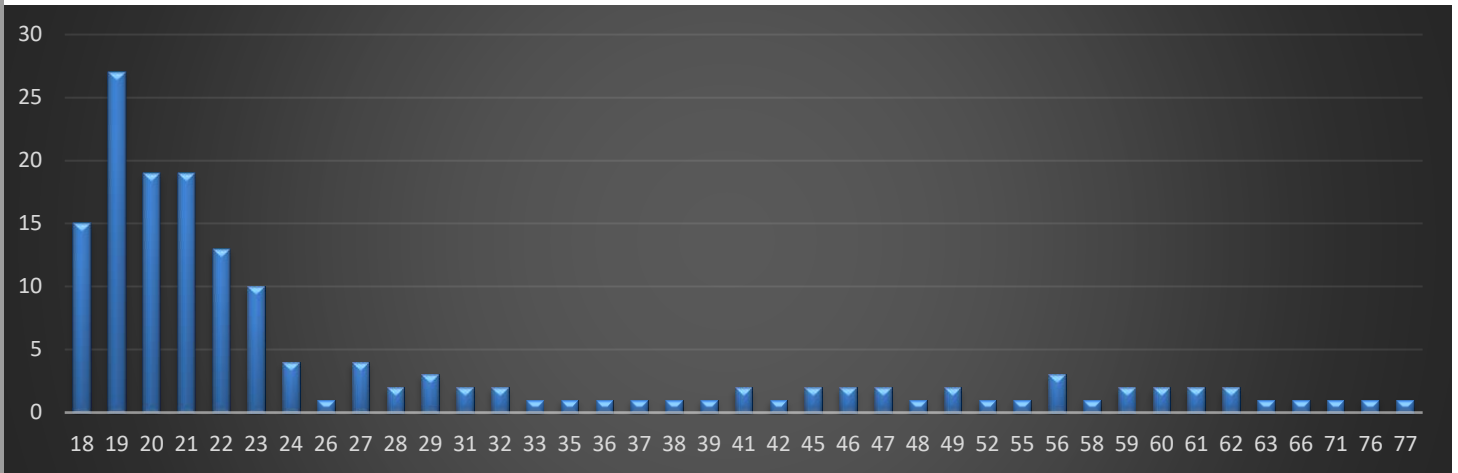
Of the 158 stops, the following chart depicts the gender of individuals upon officers initiating a stop and making contact.
