



There were a total of 152 traffic stops from Jan. 1, 2022 – Mar. 31, 2022.




Of the 152 traffic stops, the following chart depicts the ethnicity of drivers upon officers initiating a traffic stop and making contact.




Apr. 1, 2022 – June 30, 2022



There were a total of 173 traffic stops from Apr. 1, 2022 – June 30, 2022.




Of the 173 traffic stops, the following chart depicts the ethnicity of drivers upon officers initiating a traffic stop and making contact.





There were a total of 264 traffic stops from July 1, 2022 – Sept. 30, 2022.




Of the 264 traffic stops, the following chart depicts the ethnicity of drivers upon officers initiating a traffic stop and making contact.





Of the 264 traffic stops, the following chart depicts the gender of drivers upon officers initiating a traffic stop and making contact.









Oct. 1, 2022 – Dec. 31, 2022



There were a total of 258 traffic stops from Oct. 1, 2022 – Dec. 31, 2022.




Of the 258 traffic stops, the following chart depicts the ethnicity of drivers upon officers initiating a traffic stop and making contact.
